6. Program description. The IRSC is an electronic bulletin board containing information on contract awards under various GSA - IRMS contracting programs. Users have the option of displaying the data on a CRT screen or downloading the information to their own system for printing. It also includes a "feedback and hotline" for user comments and suggestions. The IRSC provides information via a menu-driven interactive computer program.

a. Availability. The bulletin board can be accessed without cost, 24 hours a day, 7 days a week through most terminals and microcomputers with communication capability.

b. Passwords. No passwords or ID's are required.

c. Technical specifications. The technical specifications are:

- (1) Asynchronous communications
- (2) Full duplex
- (3) No parity
- (4) 8 data bits
- (5) 1 stop bit
- (6) Xon/Xoff not supported
- (7) Echoing of characters provided by host system

e. Special note. When the user receives the "connect" or "on line" message at the terminal, the return (enter) key must be depressed to gain access to the bulletin board.

f. Menu. The menu provides information on the topics shown below. A menu of subtopics will be displayed under each of the main topic items. Additional menus covering other topics may be added to the system in the future.

(1) Contracts and schedules;

(2) Potential Government sources of ADP sharing and computer support; and

(3) Federal contracts and inventory of microcomputers.
